1. All service fees & transport costs are to be paid in full prior to dispatch of any semen
2. Semen fees are non refundable.
3. Semen fees are not sold with any pregnancy or live foal guarantees.
4. All semen is sold on a per dose basis. A limit of one service certificate per dose of semen purchased applies. If multiple pregnancies are achieved per dose then the Purchaser must pay an additional semen fee.
5. Transportation costs and tank hire for the semen are payable by the Purchaser. The dispatch fee charged covers two way freight and one week tank hire.
6. Overdue tanks will incur late fees on a per day basis. These are to be paid in full by the Purchaser.
7. Standard freight is considered as road freight service (delivery takes approx 5 days). Express delivery is available at additional cost.
8. Semen is not routinely insured during transport. Please advise if insurance is required. It will be charged at 8% of the invoice total. Failure to indicate will result in the semen being dispatched uninsured. INSURANCE: YES NO
9. The Purchaser acknowledges that the Seller shall not be responsible for any delays that may occur in relation to transport, import, quarantine and customs clearance of the semen to Australia. The approximate date of import of the semen is an approximate only and the Purchaser acknowledges that unexpected delays can occur. The Seller does not indemnify the Purchaser for any losses that may occur as a result of any delay that may occur. The Purchaser acknowledges that it is their responsibility to obtain insurance cover for such events.
10. A completed service certificate request form or other approved artificial insemination certificate form must be received by the Seller in order to issue a service certificate. It is the responsibility of the Purchaser to provide the Seller with this form.
11. AWHA service certificates are available for selected stallions at a cost of \$27.50 each. ACE Group service certificates are available for all stallions free of charge.
